It is clarified that the mode of execution of the Power of Attorney is explained in Notes under Form 4 and Form 5 in the Annexure to the Request for Qualification. The Notes are reproduced below for ready reference - The mode of execution of the Power of Attorney shall be in accordance with the procedure, if any, laid down by the applicable law and the charter documents of the executant(s) and when it is so required the same shall be under common seal affixed in accordance with the required procedure. The Power of Attorney shall be executed on a non-judicial stamp paper of ₹ 100 (one hundred) and duly notarized by a notary public. Wherever required, the Applicant shall submit for verification the extract of the charter documents and other documents such as a resolution/power of
