

Notice No. INCAP/D/ Development of Bhavanapadu Port/383/2011-12 Dt:13-02-2015 Introduction: Government of Andhra Pradesh, in order to boost the sea trade facilities in the state of Andhra Pradesh, proposes to develop a Greenfield port at Bhavanapadu, Srikakulam District, Andhra Pradesh

**Expression of Interest (EOI):** Infrastructure Corporation of Andhra Pradesh (INCAP), under Energy, Infrastructure & Investment Department, is the nodal agency for conducting transaction advisory for development of non-major ports in Andhra Pradesh. INCAP invites private developers(single entity or a group of entities) having development experience, technical expertise, financial capability and operational experience for development, operations and maintenance of a Greenfield port at Bhavanapadu in Andhra Pradesh under Public Private Partnership (PPP) framework in Design, Build, Finance, Operate and Transfer (DBFOT) basis.

INCAP is interested to formulate the development model and qualification criteria after taking views of the interested applicants. Based on the responses received, Request for Qualification, Request for Proposal and Draft Concession Agreement document will be prepared and will be circulated among the interested applicants who have submitted their Expression of Interest.

All other details including any date extensions, clarifications, amendments, etc., will be uploaded only to the website of INCAP and will not be published in Newspapers. Hence, applicants shall regularly visit the website of INCAP to keep themselves updated.

#### INVITATION FOR EXPRESSION OF INTEREST

#### 1. INTRODUCTION

#### 1.1. Background

- 1.1.1. Andhra Pradesh is one of the 29 states of India, located in the South-Eastern part of Peninsular India. The state has a 974 km long coastline, second longest in India, located in the South-Eastern part of Peninsular India.
- 1.1.2. The Government of Andhra Pradesh has plans to develop a non-major Greenfield port at Bhavanapadu, Srikakulam District. This proposal emanates from the fact that the hinterland of this port has a rich potential of agricultural produce, salt, marine and mineral resources. The hinterland comprises of Srikakulam and Vizianagaram districts of Andhra Pradesh and mineral rich states of Chhattisgarh, Jharkhand, Madhya Pradesh and Southern Orissa.
- 1.1.3. Besides one major port, administered under the Major Port Trusts Act, i.e. Visakhapatnam port, the state has identified 14 non-major port locations for development, administered by the Director of Ports, Kakinada, Government of Andhra Pradesh.
- 1.1.4. Of the 14 port locations, 3 non-major ports are already operating under PPP concessions by private investors, namely Gangavaram, Kakinada Deep Water port and Krishnapatnam. As of March 2014, these ports handled more than 50 million tonnes of cargo. Added to approximately 60 million tonnes of cargo handled by Vishakhapatnam Major Port, the state's coastline contributes to approximately 12% of the India's cargo throughput.

#### 1.2. Unique Advantages of the Coastline

The coastline of Andhra Pradesh has several advantages, some of which are enumerated below:

- 1.2.1. Availability of favorable sea-side features, including deep draughts and protected shore-fronts at many of the identified port locations.
- 1.2.2. The natural alignment of the coastline that makes it poised for greater competitiveness in handling cargo arriving from/destined to the Eastern hemisphere.
- 1.2.3. Availability of shore-front and land-side advantages in several Greenfield locations which are relatively unobstructed by urban sprawl, and with ability to expand as large ports.
- 1.2.4. Connectivity backbone along the coastline in the form of the South-Eastern leg of the Golden Quadrilateral network (i.e. NH16), and the Kolkata-Chennai railway route which is already operated as an electrified double line trunk route.

#### 1.3. Development trends in the hinterland

The state's ports are expected to play a critical role in shaping the future development of the state and the entire east coast. This is borne out by several economic and logistics trends.

1.3.1. Manufacturing-oriented Development and India's Look East Policy



The Government of Andhra Pradesh has adopted a balanced development model, which will have an equal focus on industries, agriculture and services. Since the state lags behind manufacturing contribution to GDP, the state Government has identified several initiatives to rejuvenate the manufacturing sector in the state, including investments in National Manufacturing Investment Zones (NIMZs), aligned with the National Manufacturing Policy (NMP). This is expected to create a large demand for shipping and logistics of raw materials and manufactured goods through the coastline.

India's Look East Policy was initiated in 1991 which seeks to establish closer ties with East Asian economies as a means to realize its aspirations of becoming a global economic superpower. The state's coastline is naturally suited for tighter integration with East Asian and South-East Asian economies in terms of participating in global manufacturing supply chains, which have hitherto largely bypassed the sub-continent, and the ports of the coastline are expected to play an important part in this process. The State government seeks to leverage its locational advantage and pursue a port-led economic development strategy that could also result in the State emerging as the node integrating India into the global manufacturing supply chain.

#### 1.3.2. Vizag – Chennai Industrial Corridor

The proposed Vizag – Chennai Industrial Corridor (VCIC), is one of the major initiatives in this regard. The proposed Corridor is a part of the East Coast Economic Corridor (ECEC), nation's first coastal corridor, aligned to the Golden Quadrilateral and is envisaged to play a key role in India's Look East Policy. The proposed Corridor shall also form an important part of the Government of India's plan for providing impetus to economic development in the region.

VCIC is expected to have an Influence Area spread across the states of Andhra Pradesh and Tamil Nadu which have significant share of contribution to national GDP and total manufacturing output of the country. 11 districts in AP (Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur, Prakasam, Nellore, Kadapa and Chittoor) fall in the influence zone. These districts represent almost 80% of the state's area and are expected to become home to various industrial nodes providing a renewed thrust to domestic and export-oriented manufacturing. This will in turn, create demand for both inbound and outbound logistics through the port networks.

#### 1.3.3. Other Manufacturing-led developments in the region

Special Investment regions like the Petroleum and Petrochemical Investment Regions (PCPIR), such as the ones near the Kakinada-Srikakulam region will create demand for commodity-specific port infrastructure. Further, other industrial corridors like Chennai-Bangalore Industrial Corridor (CBIC) and Bangalore-Mumbai Economic Corridor (BMEC) will create cargo opportunities in the secondary hinterland.

These developments will create large cargo traffic opportunities for ports in the peninsular region. However, with environmental restrictions affecting the Karnataka coastline development, BMEC may either look northwards at the congested ports of Mormugao and JNPT, or seek the Andhra Coastline for cargo evacuation facilities. Likewise, the CBIC corridor faces port capacity expansion challenges in the Chennai-Ennore region, and



therefore the industrial developments in CBIC will seek Andhra coastline as the natural choice for its cargo evacuation needs.

#### 1.4. Existing facilities at Bhavanapadu

- 1.4.1. Bhavanapadu Port is situated at latitude 18° 34' N and longitude 84° 34'E on Northern bank of Tekkali creek at about 800m inside the creek from confluence with sea. This port is about 80 nautical miles of north east of port of Visakhapatnam. A map of the location is attached for reference.
- 1.4.2. A fishery harbour exists at Bhavanapadu. The facilities of this harbour include 50 meters wide navigation channel between two rubble mound groynes, 275 meters long quay parallel to creek, auction hall, vast reclaimed open area, substation building, lighting etc., and also large open land is available around the port which can be occupied in case of need.
- 1.4.3. No commercial traffic is been handled at this harbour at present. Even the facilities available of the fully developed fishery harbour are not being used.

#### 1.5. Connectivity

- 1.5.1. The National Highway-16 from Chennai to Kolkata is at a distance of about 25 kms from Bhavanapadu. It is connected to NH-16 by means of a single lane bituminous road of 5 meters. It passes through Naupada.
- 1.5.2. The Chennai Kolkata broad gauge (BG) main lane passes about 7 kms from Bhavanapadu at Naupada Junction. There is a 90 km long branch-line from Naupada Junction upto Gunpur which has been converted into broad gauge in 2011-12.
- 1.5.3. The nearest airport is Visakhapatnam airport. Government of Andhra Pradesh is planning a Greenfield international airport at Bhogapuram near Visakhapatnam.
- 1.5.4. Government of Andhra Pradesh is also planning a beach road connecting Tada to Ichchapuram approximately 1000 Km along the coastal corridor.

#### 1.6. Project Brief

- 1.6.1. AP Government has proposed Bhavanapadu Port to be developed as a non-Major Port and for this purpose has defined the following port limits:
- 1.6.2. "Area in between the two lines drawn due east upto 10 meters of water sea ward from a point Latitude: 18° 33' N and Longitude: 84° 20' E as Southern limit and drawn due East upto 10 meters of water seaward from a point Latitude: 18° 34.7' N and Longitude: 84° 20' E as Northern Limit."
- 1.6.3. The project is proposed to be developed in 3 phases based on traffic growth. It would have access to significant traffic inflows owing to power projects in its immediate hinterland and also presence of steel plants in the secondary hinterland
- 1.6.4. Vizag-Chennai Industrial Corridor is being developed by ADB. With industrial development in the hinterland, significant traffic is expected in the port.



#### 1.7. Role of selected Applicant

- 1.7.1. The selection of the Applicant for development of the Port on Design Build Finance Operate Transfer (DBFOT) basis will be done through Public-Private Partnership model in line with the Government Guidelines.
- 1.7.2. The selected Applicant has to Design, Engineer, Finance, Procure, Construct, Operate, Maintain, Market, and Transfer the Port.
- 1.7.3. Interested national and international Applicants of repute, having international exposure in marine works are hereby invited to submit their "Expression of Interest" (EOI) for participating in global competition for Developing Bhavanapadu Port.

#### 1.8. Eligibility criteria for submission of Expression of Interest

1.8.1. The Applicant for Expression of Interest may be a single entity or a group of entities (the "Consortium"), coming together to implement the Project.

Applicants interested in the project are required to submit their Expression of Interest in writing, indicating the following Eligibility Criteria:

- a) Financial Capacity:
  - Net worth of the Applicant should be more than Rupees 800 Crores (Rupees Eight Hundred Crores).
- b) Technical Capacity:
  - The Applicant should have experience of development/construction, operations and maintenance of projects in the port sector
- c) In case of a Consortium, the combined technical capacity and net worth of the consortium members should satisfy the above conditions of eligibility
- 1.8.2. The following documents may be used to establish the eligibility
  - a) Details of the company / each member of the consortium
  - b) Audited annual accounts (P&L and Balance Sheet) of the company /all the consortium members for the last 3 years.
  - c) Net Worth certificate signed by the auditor
  - d) Details of the technical expertise and operational experience in port sector giving details for each project (Format for providing the credentials is provided in annexure to this note) –
    - Location of the project
    - Date of award of the project
    - Current status of the project
    - Cost of the project,
    - Infrastructure facilities provided etc.

#### 1.9. Stages subsequent to the submission of the EoI

1.9.1. INCAP may get in touch with the applicants submitting a response to the EOI to get further clarifications, if required.



1.9.2. After assessing the responses from the applicants INCAP will initiate the process (through the issuance of RFQ and RFP) for selecting a developer for the greenfield port at Bhavanapadu.
